## MOTION FOR EXPEDITED CONSIDERATION

COMES NOW Southern Union Company d/b/a Missouri Gas Energy ("MGE") pursuant to Commission rule 4 CSR 240-2.080(16) and states the following;

- 1. On July 26, 2007, a Unanimous Stipulation and Agreement ("Agreement") was filed which, when approved by the Commission, is calculated to resolve all issues related to MGE's proposed residential and natural gas conservation initiatives, including an energy efficient water heater rebate program. The tariffs filed by MGE on July 3, 2007, bear an effective date of August 3, 2007.
- 2. MGE requests that the Commission issue an order at its earliest possible convenience approving the Agreement and authorizing MGE to file tariff sheets in the form of those sheets filed as Exhibit 1 to the Agreement bearing an effective date of August 1, 2007, or a date as soon thereafter as is practical. MGE believes that it is important that its customers have available to them a valuable tool for controlling their natural gas commodity cost at the earliest reasonable opportunity. Any further delay in the implementation of a nature gas conservation program is not in the public interest.
