MOTION FOR EXPEDITED TREATMENT

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or the Company) and, pursuant to 4 CSR 240-2.160, submits its Motion for Expedited Treatment and states as follows:

1. Concurrent with this filing, AmerenUE submitted a revision to the tariff titled "Residential Energy Efficiency Multi-Family Income Qualified Program." This tariff was filed with a 30 day effective date, meaning it would become effective February 26, 2010, unless the Missouri Public Service Commission (Commission) takes action to approve the tariff earlier.

2. Pursuant to 4 CSR 240-2.080(16), AmerenUE requests the Commission issue an order approving the tariff so that it may be effective no later than February 10, 2010.

3. The revised tariff allows AmerenUE to pay the installer directly, rather than paying the incentive to the building owner. In addition, it requires a commitment to improve common areas of the buildings.

4. AmerenUE has filed this request as soon as possible after deciding the tariff change was necessary. The Company has been working with Commission Staff in order to facilitate as much agreement on the tariff language as possible. There will be no

negative effect on the party's customers or the general public in granting this expedited treatment request.

WHEREFORE, AmerenUE respectfully requests the Commission issue an order approving the revised Residential Energy Efficiency Multi-Family Income Qualified Program tariff so that it is effective no later than February 10, 2010.
