## MOTION FOR EXTENSION OF TIME TO FILE JOINT LIST OF ISSUES, ORDER OF WITNESSES, CROSS EXAMINATION AND OPENING STATEMENTS, JOINT STIPULATION OF FACTS, AND POSITION STATEMENTS

**COMES NOW** Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and states for its Motion as follows:

- 1. On December 11, 2012, the Commission issued a procedural schedule in this matter directing Staff, the Office of the Public Counsel and Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"), known herein as "the parties," to file a Joint Issues List, Witnesses List, Order of Witnesses, Order of Cross-Examination, and Order of Opening Statements by February 26, 2013.
- 2. By the same Order, the Commission also directed the parties to file a Joint Stipulation of Non-Disputed Material Facts and Position Statements on February 27, 2013, and February 28, 2013, respectively.
- 3. Staff reports to the Commission that Ameren Missouri and Staff are engaged in productive settlement discussions and request a short extension to continue the discussions in the hope of presenting a resolution to the Commission for its approval.
- 4. Staff requests the Commission extend the filing deadlines of the Joint Issues List, Witnesses List, Order of Witnesses, Order of Cross-Examination, and Order

of Opening Statements, as well as the Joint Stipulation of Non-Disputed Material Facts until Thursday, February 28, 2013. Staff further requests the Commission extend the filing deadline of the Position Statements until Friday, March 1, 2013.

5. Ameren Missouri supports this request.

WHEREFORE, Staff files this Motion for an extension of time and requests the Commission to approve the extension of filing deadlines as proposed in paragraph four (4) above.
