MOTION FOR ONE DAY EXTENSION OF TIME
TO FILE TRUE-UP REBUTTAL TESTIMONY

Comes now, Lake Region Water & Sewer Company (Lake Region), by and through its attorneys, and pursuant to 4 CSR 240-2.050(3) submits the following to the Commission:

1. Pursuant to the procedural schedule adopted by the Commission in this case on November 17, 2009, true-up rebuttal testimony is due to be filed by the parties today, April 21, 2010.

2. Since the filing of true-up direct testimony on April 16, 2010, Lake Region has been reviewing workpapers of the Missouri Public Service Commission Staff (Staff). Lake Region discovered a formula error in Staff's true up workpapers regarding depreciation reserve. Staff has corrected that error and new exhibit modeling system (EMS) runs were forwarded to Mr. John R. Summers, Lake Region's only true-up rebuttal witness, over the noon hour today.

3. Lake Region and Mr. Summers need additional time to evaluate Staff's new EMS runs in connection with finalization of the Company's true-up rebuttal testimony. Lake Region seeks a one day extension of time within which to file the same.

4. This request is not for purposes of delay but rather is filed for good and sufficient cause.

WHEREFORE, Lake Region respectfully requests the Commission for an extension of one day, up to April 22, 2010, within which to file true-up rebuttal testimony.
