RESPONSE OF KANSAS CITY POWER & LIGHT COMPANY AND KCP&L GREATER MISSOURI OPERATIONS COMPANY

As directed by the Commission's February 26, 2010 Order, KCP&L and KCP&L GMO submit their response to the Staff's Recommendation to Deny Accounting Authority Order.

1. Pursuant to 4 CSR 240-2.116, the Companies withdraw their application for an Accounting Authority Order. As staff recognized on pp. 5-6 of its recommendation, the Companies will address the costs incurred to date to comply with Proposition C in their upcoming rate cases. The Companies anticipate, based on Staff recommendation, receiving recovery of the costs incurred as a result of Proposition C in the test period and therefore, no additional action is necessary in this docket.

2. Additionally, the Commission has scheduled the filing of comments and a hearing on April 6th to consider a rulemaking pertaining to the recovery of costs associated with Proposition C. KCP&L and KCP&L GMO, on behalf of themselves or through MEDA, intend to file comments to address concerns with the proposed rulemaking. The Companies hope the Commission will act on the comments and address much of the reason for this Accounting Authority Order application in the adoption of Proposition C rules. The Companies will request that the Commission consider provisions in the Proposition C rulemaking to allow for recovery of renewable resource acquisition strategies that exceed the requirements of the compliance plan set out in the proposed rules. The Companies will also request the Commission consider in its rulemaking alternatives beyond what is currently included in the proposed rule for cost recovery. These comments, as well as others, are anticipated to be filed and addressed at the April 6th hearing.
