## LIBERTY UTILITIES' MOTION TO AMEND BY INTERLINEATION PREVIOUSLY FILED RECONCILIATION

COMES NOW Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities ("Liberty Utilities" or "Company") and, pursuant to Commission Rule 4 CSR 240-2.080(18), respectfully moves the Commission to accept the attached one-page revision (in both NP and P/HC versions) to the Reconciliation previously filed in this matter on February 5, 2015. In support thereof, Liberty Utilities states as follows:

- 1. As set forth in its previously filed Response and proposed Reconciliation, Liberty Utilities prepared a reconciliation, which was attached thereto as Exhibit A, which it believes satisfies the requirements of Section 386.420.4 RSMo. Due to the confidential nature of certain information reflected in some of the sub-issues decided by the Commission, Exhibit A was submitted in both Non-Proprietary ("NP") and Proprietary/Highly Confidential ("P/HC") versions.
- 2. It has come to the attention of the Company that the last page of the Reconciliation (Exhibit A, page 16 of 16) contains a *de minimis* error regarding customer counts for the "Large Gen Gas Svc Sch & Transp" customer class for the NEMO and SEMO Districts, to-wit: for NEMO, at Line 8, the Total MO Customer Counts (Column k)

should be 115 rather than 121; and for SEMO, Line 35, Column (k) should reflect 152 customers rather than 158. There are no changes in the Mcf Volumes regarding this minor reduction of six (6) customers in each district, and the resulting \$3,000 annual revenue impact for both districts is *de minimis* as well. Accordingly, the attached revised Page 16 of 16 (in both NP and P/HC versions) reflects changes to Columns (k) and (m) at Lines 8, 16, 26, 35, 43, 52, 72, 74, 86, 94 and 104.

WHEREFORE, Liberty Utilities respectfully requests that the Commission accepts its "Exhibit A Revised Reconciliation Page 16 of 16" attached hereto and, after considering any responses filed by other parties, approve the previously filed Reconciliation, as amended herein.
