## **EIGHTEENTH STATUS REPORT**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and for its <u>Eighteenth Status Report</u> states the following to the Missouri Public Service Commission ("Commission"):

- 1. After the Staff had filed a <u>Status Report</u> on May 9, 2006<sup>1</sup>, the Commission issued its <u>ORDER DIRECTING STAFF TO FILE STATUS REPORTS</u> ("Order") on May 12<sup>th</sup>, in which it ordered the Staff to submit monthly status reports on or before the 15<sup>th</sup> of each month until such time as a recommendation can be filed, or unless otherwise ordered by the Commission.
- 2. In compliance with the Commission's Order, the Staff submitted its <u>Second Status</u> Report on June 15<sup>th</sup>, its <u>Third Status Report</u> on July 12<sup>th</sup>, its <u>Fourth Status Report</u> on August 15<sup>th</sup>, its <u>Fifth Status Report</u> on September 15<sup>th</sup>, and its <u>Sixth Status Report</u> on October 12<sup>th</sup>, its <u>Seventh Status Report</u> on November 15<sup>th</sup>, its <u>Eighth Status Report</u> on December 15<sup>th</sup>, and its <u>Ninth Status Report</u> on January 12<sup>th</sup>, 2007, its <u>Tenth Status Report</u> on February 15<sup>th</sup>, 2007, and its <u>Eleventh Status Report</u> on March 15<sup>th</sup>, 2007, its <u>Twelfth Status Report</u> on April 13<sup>th</sup>, 2007, its <u>Thirteenth Status Report</u> on May 14<sup>th</sup>, 2007, its <u>Fourteenth Status Report</u> on June 15<sup>th</sup>, 2007, its <u>Fifteenth Status Report</u> on July 16<sup>th</sup>, 2007, its <u>Sixteenth Status Report</u> on August 15<sup>th</sup>, 2007, and its <u>Seventeenth Status Report</u> on September 15<sup>th</sup>, 2007.

3. On September 11, 2007 the Commission issued its <u>ORDER DIRECTING STAFF TO</u> <u>FILE QUARTERLY STATUS REPORTS</u>. In this order, the Commission directed the Staff to submit quarterly status reports beginning on January 15, 2008.

4. For this Eighteenth Status Report, the Staff reports that, since the Purchase and Sale Agreement (Agreement) entered into between Public Water Supply District No. 1 of Lincoln County (the District) and Lincoln County Utilities (LCU) has expired, the parties have been working on an extension of the Agreement. Although the owners of LCU state that they have signed the extension to the Agreement, and returned it to their counsel, the District states that it does not yet have the signed extension to the Agreement. Thus, it has not undertaken further work with regard to this proposal since at present it does not have a contract for acquisition of LCU's assets. One of the owners of LCU states that they are working on getting the signed document to the District.

WHEREFORE, the Staff respectfully submits this <u>Eighteenth Status Report</u> for the Commission's information.
