**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *List and Order of Witnesses, Order of Opening Statements, and Order of Cross-Examination,* states as follows:

1. On April 27, 2011, the Commission set an evidentiary hearing for August 1 and 2, 2011, to determine "whether KCP&L Greater Missouri Operations Company violated the terms and conditions of the Nonunanimous Stipulation and Agreement in File No. EE-2009-0237."<sup>1</sup>

2. On February 8, 2011, Staff filed its Complaint, docketed as Case No. EC-2011-0250, one allegation of which is that "GMO violated the *Nonunanimous Stipulation*

and Agreement of April 12, 2010, approved by the Commission on June 2, 2010."<sup>2</sup>

3. On July 5, 2011, the Commission issued its *Order Establishing Requirements for Evidentiary Hearing,* requiring (1) that any party proposing to offer expert testimony at the hearing disclose the identity and biographical background of each such expert witness not later than July 25, 2011; and (2) that the several parties shall agree, and Staff shall file, a list of the witnesses to appear on each day of the hearing, the order in which they will be called, and the order of party cross-examination for each witness.

WHEREFORE, Staff submits the attached *List and Order of Witnesses*, Order of Opening Statements, and Order of Cross-Examination.
