MOTION FOR EXTENSION OF TIME TO SEND NOTICE TO CUSTOMERS

Comes now Northwest Missouri Holdings, Inc. and Oregon Farmers Mutual Telephone Company ("Joint Applicants") and for their Motion for Extension of Time to Send Notice to Customers states to the Missouri Public Service Commission ("Commission") as follows:

1. On March 9, 2004, Joint Applicants filed their Joint Application seeking authority for Northwest Missouri Holdings Inc. to acquire all of the outstanding shares of Oregon Farmers Mutual Telephone Company.

2. On March 10, 2004, the Commission issued its Order Directing Notice, Directing Filing and Adopting Protective Order. Among other things the Commission directed the Joint Applicants to provide notice to each of the customers of Oregon Farmers Mutual Telephone Company and file proof of service in the case within ten (10) days of the date the Order was issued. Accordingly, Joint Applicants are required to send notice to their customers and file proof of same with the Commission no later than March 20, 2004.

3. In order to avoid the additional cost of a separate mailing, Joint Applicants request that the Commission grant them extension of time so that they may send notice

to the Oregon Farmers Mutual Telephone Company customers with their April 1, 2004, billing. This will allow Joint Applicants to avoid the additional expense of a separate mailing and, at the same time, adequately and timely inform the Oregon Farmers Mutual Telephone Company customers of the proposed sale and transfer of stock.
