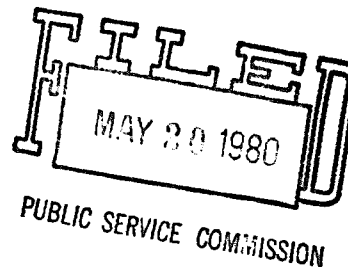

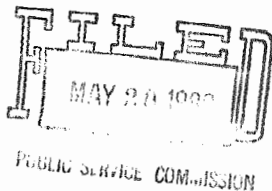
On February 21, 1980, the Water's Edge Sewer Company submitted to this Commission for permission and approval and for a certificate of convenience and necessity authorizing it to construct, install, own, operate, control, maintain and manage a public sewer system in Boone County, Missouri.

On March 3, 1980, this Commission entered an Order and Notice of hearing affording interested persons an opportunity to present evidence either in support of or in opposition to the authority sought.

Columbia is an "interested person" in that sewage facilities and sanitary conditions in the vicinity of the City of Columbia which could, at some future date, become part of the City are matters having direct bearing on the public health, welfare and safety of the residents of the City of Columbia.

WHEREFORE, by reason of the foregoing, Columbia prays that its Application to Intervene be granted in accordance with 4 CSR 240-2.110 (16), with full rights as a party in the above-captioned proceedings, so that it may support the interests of itself and its residents as they shall appear, but for the purposes of the present application specifies that it is opposed to authorizing Water's Edge Sewer Company to construct, install, operate, own, control, manage or maintain a public sewer system in Boone County, Missouri.
