**NOTICE AND MOTION TO
ACCEPT OUT OF TIME**

AT&T Missouri,¹ pursuant to the Missouri Public Service Commission's ("Commission's") January 10, 2006 Order,² respectfully notifies the Commission that business service rates in AT&T Missouri's Greenwood exchange increased by one dollar as part of the rate increase for business service (flat-rate one party, flat-rate trunk and multiline trunk) in all competitively classified exchanges.³

Pursuant to the Commission's Order, this Notice was to be filed in this case within two weeks of any MCA rate increase for the Greenwood exchange. AT&T Missouri just realized that it had failed to provide this Notice and apologizes for this inadvertent omission. AT&T therefore respectfully requests that the Commission accept this Notice out of time.


