

On October 16, 2001, Union Electric Company d/b/a AmerenUE filed its Final Earnings Report for the Third Sharing Period of the Second Alternative Regulation Plan (EARP II) pursuant to the Stipulation and Agreement approved by the Commission on February 21, 1997. Paragraph 7.f.x. of that Stipulation and Agreement provides signatory parties 30 days after the final report is filed to provide notice of any areas of disagreement not previously brought to the attention of the Commission that need to be resolved. On November 15, 2001, the Office of the Public Counsel filed its Notice of its Areas of Disagreement. This case shall be reopened for consideration of these pleadings.
