

NOTICE REQUIRING FILING

KLM Long Distance Company (KLM) applied to the Missouri Public Service Commission (Commission) on May 26, 2000, for an order granting a certificate of service authority to provide interexchange and local exchange telecommunications services in Missouri.

KLM indicated that it will provide services under the name of "KLM Long Distance." Commission Rule 4 CSR 240-2.060(1)(E) states that all applications shall include, if any applicant does business under a fictitious name, a copy of the registration of the fictitious name with the Secretary of State. KLM's application does not comply with Commission Rule 4 CSR 240-2.060(1)(E) in that it does not include a copy of the registration of the fictitious name with the Secretary of State.

The Commission cannot proceed with this case until KLM files pleadings in conformance with the Commission's rules.


