If any communication of this sort has occurred in the previous sixty (60) day period, I further certify this application was held until sixty (60) days have passed from the date of the subject communication, or we have requested a waiver for good cause as allowed by Commission Rule 20 CSR 4240-4.017(1)(D).

This language is incorporated in the application form and affidavit included on the Commission's website as paragraph 9 of the affidavit.

The Commission will not take action on United Services, Inc.'s Notice of Change Application seeking to expand video service until this deficiency is corrected.
