1. On January 2, 2008, the Commission issued an order directing Staff to investigate KCP&L's response to the December 2007 ice storm experienced in its service territory. On April 3, 2008, Staff filed an initial report of its investigation with the Commission, followed by a final report submitted on June 17, 2008.
2. Staff's June 17, 2008 Final Report contained twenty-four (24) recommendations on how KCP&L could improve its response in future storms. KCP&L filed a response to Staff's recommendations on August 15, 2008.
3. On September 9, 2008, the Commission issued an order directing "KCPL to provide Staff with additional information regarding its progress in complying with Staff's recommendations." The Commission further ordered Staff to file a brief supplemental report evaluating the Company's compliance with Staff's recommendations.
4. Attached hereto is Staff's Memorandum, completed by Michael Taylor, Utility Engineering Specialist, and Kay Niemeier, Utility Management Analyst.

5. Staff's Memorandum contains specific discussion on certain recommendations, along with the overall conclusion that KCP&L has achieved compliance with Staff's June 17, 2008 recommendations, or is taking appropriate action to do so.
6. Staff will continue to monitor KCP&L's actions toward completion of Staff's recommendations.

WHEREFORE, the Staff submits its Supplemental Report to the Missouri Public Service Commission.

Subject: Staff Supplemental Report

Date: January 9, 2009

The Staff of the Missouri Public Service Commission (Staff) has evaluated Kansas City Power and Light Company's (KCP&L's) Status Update to Staff Recommendations Regarding Storm Preparation and Restoration Efforts. The status update was submitted on November 10, 2008 to comply with a Commission Order issued September 9, 2008. The Order also required a Supplemental Report from Staff.

The Final Report of Staff's Investigation included twenty-four (24) recommendations, some recommendations contained multiple parts. Based on Staff's evaluation of KCP&L's compliance with the recommendations contained in the report, the following determinations resulted.

1. KCP&L has agreed with the substance of all the recommendations and has initiated or completed action to implement appropriate changes to their procedures, processes, and policies.
2. Based on KCP&L's status update submitted on November 10, 2008 and additional Staff discussions with KCP&L personnel, approximately 80% of the actions are completed or scheduled for completion by January 31, 2009.
3. The remaining actions are scheduled for completion in the first half of 2009 or will be completed at a time to be determined (these items include such actions as participation in a storm restoration workshop).
4. The scheduled completion dates for all pending items appear reasonable.

Staff determined that, from an overall perspective, KCP&L has achieved compliance with Staff's recommendations or is taking appropriate action to do so.

Staff will continue to monitor progress of completion of the KCP&L actions. The recent transition of Aquila, Inc. to KCP&L Greater Missouri Operations Company (GMOC) will

require integration of KCP&L's corrective actions with GMOC, where appropriate. The completion and effectiveness of that integration will also be monitored by Staff.



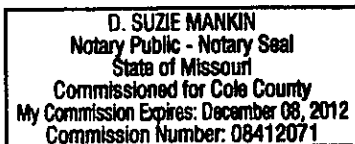
