# MOTION TO SUSPEND TARIFF AND REQUEST FOR INTERVENTION

COMES NOW CenturyTel of Missouri, LLC ("CenturyTel"), pursuant to 4 CSR 240-2.065 (3) and 4 CSR 240-2.075 respectfully files its Motion To Suspend Tariff And Request For Intervention ("Motion") in this proceeding. In support of its Motion, CenturyTel states as follows:

1. On September 8, 2004, Socket Telecom, LLC ("Socket") filed proposed tariff sheets for Socket Telecom, LLC's P.S.C. Mo. No. 2 (Attached as Exhibit No. 1) which are apparently intended to allow Socket to engage in market trials that will enable Socket to test its ability to provide local exchange services in various geographic areas where the company plans to provide local services. These market trials may include local exchanges presently served by CenturyTel of Missouri, LLC. The local exchange services would be provided during the market trial at no cost to the consumer in violation of Section 392.220.3, RSMo. In addition, while the market trial is intended to last a maximum of 12 weeks, the proposed tariff does not have a specific ending date for the trial which is contrary to custom and practice for previously approved market trials approved by the Commission. For the reasons stated herein, CenturyTel respectfully requests that the proposed tariffs of Socket be suspended, the matter set for hearing, and that CenturyTel be granted intervention in the proceeding.

- 2. Socket is proposing to offer its market trial for free, or at no charge, to all trial participants in violation of RSMo 392.220.3 which states, "No telecommunications company subject to the provisions of this law shall, directly or indirectly, give any free or reduced service, or any free pass or frank for the provision of telecommunications services between points within this state, except to its officers, employees, agents, surgeons, physicians, attorneys at law and their families; to persons or corporations exclusively engaged in charitable and eleemosynary work and ministers of religions; to officers and employees of other telegraph corporations and telephone corporations, railroad corporations and street railroad corporations; public education institutions, public libraries and not-for-profit health care institutions. This subsection shall not apply to state, municipal or federal contracts."
- 3. Finally, Socket claims that "the Company may need to test the capabilities of the systems required by a proposed service, including, but not limited to systems needed to establish, provision, operate, bill and/or collect for service, whether such systems are provided solely by the Company or in combination with systems provided by other carriers or vendors." A "no charge" trial would not allow Socket to test the accuracy of its billing and other back office support systems, which is arguably one of the most crucial elements for the provision of telecommunications services as far as consumers are concerned. There is no apparent reason in testing a system for which a business entity cannot account, bill or collect for service.
- 4. Unlike market trials approved in the past for Fidelity, AT&T and Time Warner, Socket has proposed no end date for its trial. Socket's proposed tariff only states that, "[e]ach trial will last for a maximum of 12 weeks." Socket provides no

beginning or end dates. It can only be inferred that a trial may begin October 8, 2004, the effective date of the tariff. By not providing a date certain when a market trial will end in effect gives Socket a perpetual market trial since the Commission will not know when or where a 12-week trial is to begin or end. In a previously approved market trial in Case No. LT-2004-0523, Time Warner specifically specified that their market trial would "end on September 9, 2004." CenturyTel believes that the Commission should require that Socket's trial have a specific ending date.

5. Assuming that the Commission grants CenturyTel's Motion To Suspend Tariff, CenturyTel would also request that the matter be set for hearing and that CenturyTel be permitted to intervene in the proceeding. 6. CenturyTel is a Louisiana limited liability corporation that is duly authorized to do business in the state of Missouri. Copies of CenturyTel's Certificate of Authority to transact business in Missouri from the Missouri Secretary of State were filed in Case No. TM-2002-232, In the Matter of the Joint Application of GTE Midwest, Inc., d/b/a Verizon Midwest and CenturyTel of Missouri, LLC for 1) Authority to Transfer and Acquire Part of Verizon Midwest's Franchise, Facilities and System Located in the State of Missouri; 2) For Issuance of Certificate of Service Authority to CenturyTel of Missouri, LLC; 3) To Designate CenturyTel of Missouri, LLC as Subject to Regulation as a Price Cap Company; and 4) To Designate CenturyTel of Missouri, LLC as a

Telecommunications Carrier Eligible to Receive Federal Universal Service Support, and

are incorporated herein by reference pursuant to Commission Rule 4 CSR 240-

2.060(1)(G). Pursuant to the Commission's Report and Order issued in Case No. TM-

2002-232, CenturyTel provides basic local and interexchange telecommunications

7. CenturyTel has no pending action or final unsatisfied judgments or

decisions against it from any state or federal agency or court which involve customer

service or rates, which action, judgment or decision has occurred within three (3) years

of the date of the Application. No Missouri annual reports or assessment fees are

overdue.

8. CenturyTel's interests in this matter are different from that of the general

public. Granting CenturyTel's application will serve the public interest. CenturyTel

states that it is opposed to Socket's proposed tariff.

WHEREFORE, CenturyTel of Missouri, LLC prays that the Commission suspend the tariffs filed in this matter by Socket on September 8, 2004 (as substituted on September 20, 2004), set the matter for hearing, and permit CenturyTel to participate as an intervenor in this proceeding, and for such other and further relief as the Commission deems appropriate.
