**MOTION TO WITHDRAW OF
UNION ELECTRIC COMPANY d/b/a AMEREN MISSOURI**

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”), by and through counsel, and hereby files its Motion to Withdraw. In support of this request, Ameren Missouri respectfully states:

1. On July 22, 2011, the Commission issued an order opening a new case (File No. ET-2012-0017) regarding the carrying costs for the phase-in tariffs for KCP&L Greater Missouri Operations Company ("GMO").

2. With its July 22 order in File No. ET-2012-0017, the Commission provided that parties to File No. ER-2010-0356, GMO's recently completed rate case, shall be made parties to the new proceeding without the need for further intervention. The July 22 order also established dates for the filing of testimony and set a date for an evidentiary hearing regarding the carrying costs for GMO's phase-in tariffs.

3. On July 25, 2011, the Commission closed File No. ET-2012-0017, opened File No. ER-2012-0024, and stated that the procedural schedule adopted in ET-2012-0017 shall be the procedural schedule in this matter (ER-2012-0024).

4. Ameren Missouri was granted intervention as a party to GMO's rate case (ER-2010-0356). Pursuant to the Commission's July 22nd order, Ameren Missouri was automatically made a party to File No. ET-2012-0017 and then to this proceeding (ER-2012-0024).

5. This proceeding (File No. ER-2012-0024) involves the limited issue of the carrying costs for GMO's phase-in tariffs, and Ameren Missouri hereby seeks to withdraw from this proceeding in order to conserve resources.

WHEREFORE, Union Electric Company d/b/a Ameren Missouri respectfully requests an order of the Commission granting its motion withdraw from this case. Ameren Missouri requests such other and further relief as the Commission deems just and proper under the circumstances.
