

COMES NOW, Missouri School Boards' Association (hereafter "MSBA") by and through its Counsel, Hendren and Andrae, L.L.C., Richard S. Brownlee, III, and for its Motion to Amend Procedural Schedule states:

1. By its Order of August 29, 2002, the Missouri Public Service Commission (hereafter "Commission") issued its Order Adopting Procedural Schedule and Expediting Transcript. Said Order required inter alia, the following compliance dates:

2. Attorney for intervener MSBA has a long scheduled engagement that will take him out of the country until October 4, 2002; therefore he would not be able to participate in the October 3, 2002 hearing.

3. In the related case of GT-2003-0034 - Proposed Gas Aggregation tariff of Union Electric Company, d/b/a AmerenUE, the Commission issued its Order Adopting Procedural Schedule and

Proposed Findings of Fact, Conclusions of Law, and Briefs	October 10, 2002




