**SUGGESTIONS IN SUPPORT OF NORANDA’S  
MOTION FOR EXTENSION OF TIME**

**COME NOW** Consumers Council of Missouri (CCM), the Office of the Public Counsel (OPC), and the Missouri Retailers Association (MRA) and in support of the Motion to Modify the Procedural Schedule filed by Complainants in this case, state:

As CCM, MRA and OPC noted in their Motion for Reconsideration filed on May 27, 2014, Complainants have the burden of persuasion in this case, despite not having had discovery prior to the filing of the Complaint. As noted in our Motion for Reconsideration (Paragraph 7), the other parties to the complaint case may and should raise in their rebuttal testimony all relevant factors for the Commission to consider in this general rate proceeding.

Because Complainants’ earliest opportunity to address any additional factors raised by other parties is surrebuttal testimony, an additional seventeen (17) days is warranted for review of the rebuttal testimony, work papers and records supporting any new issues.

CCM, OPC and MRA also note that the additional time sought by the Complainants will not require any other adjustment to the current procedural schedule.

WHEREFORE, CCM, OPC and MRA ask the Commission to grant Complainants' Motion for Extension of Time to File Surrebuttal Testimony.
