ORDER CONCERNING MOTION TO MODIFY

On November 16, 1994, Missouri Gas Energy (MGE) filed its motion with the Commission to modify its order in this matter to adopt a modified replacement and protection plan. On December 2, 1994, the Commission expressed its concerns regarding the proposed plan and requested further information from the parties. On December 7, 1994, MGE filed its response, followed by the response of the response of the Staff of the Commission, on November 8, 1994.

After review, the Commission finds the detail contained in the responses to be insufficient to alleviate the concerns of the Commission as set out in its order of December 2, 1994. In that order, the Commission stated:

"As the Commission has not been furnished with sufficient detailed information by either of the parties in this case as to the reasons for concluding that the proposed modification is sufficient to ensure the public safety, the Commission will allow the parties adequate time in which to prepare additional justification as to the reasons for and the necessity of this proposal and the reasons for abandoning the original plan. The Commission would note that any submission by either of the parties should contain a full explanation as to why no compromise in public safety will result should the MGE proposal be adopted."

The Commission, therefore, feels compelled to set this matter for a presentation by the parties, to be held on the record at 1:30 p.m., December 29, 1994, in the Commission's offices in the Harry S Truman State Office Building, Room 520B, 301 W. High Street, Jefferson City, Missouri. This presentation will be for the purposes as set out above.

IT IS THEREFORE ORDERED:

1. That an on the record presentation by the parties and for the reasons as set out above will be held on December 29, 1994 at 1:30 p.m., December 29, 1994, in the Commission's offices in the Harry S Truman State Office Building, Room 520B, 301 W. High Street, Jefferson City, Missouri.

2. That this order shall become effective on the date hereof.

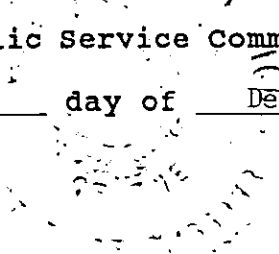
