The Commission has reviewed the application filed by Spectrum Mid-America, LLC and finds that it and the attached affidavit comply with the filing requirements set forth in Section 67.2679.7, RSMo 2016. Spectrum Mid-America, LLC is granted authority to construct a video service network along, across, or on public rights-of-way for the delivery of video service to the extent the video service provider or an affiliate did not otherwise possess a valid authorization to occupy the public rights-of-way.
- 4. This order shall become effective when issued, after which this file may be closed.
