MOTION TO SUSPEND PROCEDURAL SCHEDULE

COME NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or the "Company"), on behalf of itself and the Staff of the Missouri Public Service Commission, the Office of the Public Counsel, Missouri Division of Energy, Consumers Council of Missouri, Natural Resources Defense Council, Kansas City Power & Light Company, Spire Missouri, Inc., Renew Missouri Advocates d/b/a Renew Missouri, National Housing Trust, and Tower Grove Neighborhood Community Development Corporation, and the Midwest Energy Consumers Group (collectively referred to as the "Parties"),¹ and hereby request that the Procedural Schedule approved by Commission order issued August 1, 2018, be suspended due to the pending settlement of this case. In support of is request, Ameren Missouri states as follows:

1. On October 4, 2018, the Parties in this matter met to discuss potential settlement of the issues. The Parties have reached a settlement in principle, to which all Parties have tentatively agreed to either sign or not object. The Parties have continued efforts towards commemorating that agreement in writing.

2. The procedural schedule established in this case included an evidentiary hearing scheduled to occur from October 15 through October 19, 2018. In light of the ongoing efforts to

present a complete settlement of this matter for the Commission's decision, the Company, on behalf of all of the Parties, requests that the procedural schedule be suspended.
