The Company did not renew its "IE Com" trade name with the Secretary of State.

Matrix respectfully requests that the Company's Certificates of Authority and all other Commission records be updated to reflect the change in name to Matrix Telecom, LLC and an effective date of May 20, 2016 for the enclosed Adoption Notices and revised tariff title pages.

Additionally, the Electronic Filing and Information System (EFIS) will be reviewed and updated concurrently with this filing, if applicable.
