On December 15, 2008, the Staff of the Missouri Public Service Commission filed requests for the Commission to establish cases, provide notice, set intervention deadlines and schedule an early prehearing conference for the purpose of establishing records of consideration and determinations as to whether to adopt new standards for regulated electric companies encompassed within the Energy Independence and Security Act of
