2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.

3. Spectrum Mid-America, LLC is granted authority to construct a video service network along, across, or on public rights-of-way for the delivery of video service to the extent the video service provider or an affiliate did not otherwise possess a valid authorization to occupy the public rights-of-way.

4. This order shall become effective when issued, after which this file may be closed.
