Enclosed please find the STS Annual Report for 2002 for Kansas City Executive Suites, Inc. (KCES). KCES was forced to cease all business operations on July 31, 2002. It had been operating in the red for quite some time and all cash reserves were expended. It has since been administratively dissolved by the office of the Secretary of State of Missouri. The few tenants who were still with KCES at that time that it ceased operation were all successfully switched to other telephone services.

Apparently, my co-owner in the company, Mr. Richard Conway, who had been preparing the STS Annual Report for the last several years, neglected to file it for 2002. I just recently became aware of this oversight through my attorney, Mr. Norris Greer. When the Commission filed a complaint (Case No. TC-2004-0408), for failure to file the report, they contacted Mr. Greer who then contacted me and Mr. Conway. I immediately contacted the Associate General Counsel assigned to the case, Mr. Bruce Bates. He recommended that I complete and file the STS Annual Report for 2002. Through our attorney, I asked Mr. Conway to prepare and file the report with the Commission, as he had done for the last several years. He communicated back through our attorney that he was not going to prepare or file the report. I have prepared the enclosed report to the best of my ability, based upon the records that I have from the business. Please let me know if there is anything else that I can do to comply with the regulations and procedures of the Commission. My address and phone number are in the report.
