MOTION TO WITHDRAW

COMES NOW the Missouri Joint Municipal Electric Utility Commission ("MJMEUC") and, in accordance with 4 CSR 240-2.080, requests to withdraw as a party in the above-referenced case and, in support of its motion to withdraw, respectfully states as follows:

1. On February 21, 2002, the Missouri Public Service Commission ("MoPSC" or "Commission") issued its Order Approving Stipulation and Agreement in Case No. ER-2002-672. MJMEUC was a signatory party to that Stipulation and Agreement.
2. An element of the Stipulation and Agreement was the establishment by the Commission of a "spin-off docket" in which to examine class cost of service and rate design in Aquila's Missouri jurisdictional electric service operations.
3. The Commission has established this case for that purpose, and has made all of the parties to Case No. ER-2002-672, including MJMEUC, parties to this case.
4. As a wholesale energy customer of Aquila, directly and on behalf of its contracting municipalities, the MJMEUC and its municipalities are not subject to the Aquila retail tariffs and will thus not be significantly affected by the outcome of this case.

WHEREFORE, having stated its grounds for withdrawal, the MJMEUC requests the Commission to enter its Order granting leave to withdraw as a full party in this case, and for such other and further relief as the Commission may deem appropriate.
