MOTION TO ADMIT *PRO HAC VICE*


Pursuant to Rule 9.03 of the Supreme Court of Missouri and 4 CSR 240-2.040(3)(C),
Curtis D. Blanc, on behalf of Kansas City Power & Light Company ("KCPL"), states as follows:

1. Movant is employed by KCPL as a Senior Attorney. Movant's business address is 1201 Walnut, Kansas City, Missouri, 64106.
2. Movant submitted an application for admission to the Missouri Bar without examination several months ago. That application is currently pending before the Missouri Board of Law Examiners and the Supreme Court of the State of Missouri. 
