MOTION FOR EXPEDITED TREATMENT

COMES NOW Kansas City Power & Light Company ("KCP&L"), pursuant to 4 CSR 240-2.080(14), and hereby requests expedited treatment and approval by the Missouri Public Service Commission ("Commission") of KCP&L's revised tariff sheets attached hereto in above-captioned matter.

- 1. On September 23, 2013, KCP&L, Staff of the Missouri Public Service Commission, Midwest Energy Consumers Group and Missouri Industrial Energy Consumers (collectively, the "Signatories") entered into and filed a Non-Unanimous Stipulation and Agreement ("Stipulation") in the above-captioned matter.
- 2. As outlined on pages two-three of the Stipulation, "KCP&L will file the revised rate schedules in Attachment A, which are agreed to by the Signatories and which include a non-MEEIA energy efficiency charge of \$0.00081 per kWh that qualified opt-out customers can avoid." Therefore, pursuant to the Stipulation and 4 CSR 240-2.080(14), the Companies hereby request expedited treatment and approval of its new tariff sheets:

3. On October 3, 2013, the Commission filed its Order Approving Stipulation and Agreement with an effective date of October 13, 2013. The tariffs filed contemporaneously with this pleading bear a 30-day effective date. KCP&L requests that the tariffs become effective in 10 days (i.e. October 20, 2013) since all of the parties have already reviewed and approved the tariffs. There will be no harm to the general public if this motion is granted. This pleading was filed as soon as it could have been after the tariffs were filed.

WHEREFORE, for the foregoing reasons, KCP&L respectfully requests that the Commission grant it expedited treatment and approval of its new tariff sheets as outlined in paragraph 2 above and filed herewith.
