Dear Judge Roberts:

This letter is filed on behalf of One Call Communications, Inc. (One Call) pursuant to 4 CSR 240-2.060 (16) to request approval of a change of name under which the company operates in the State of Missouri.

The records of the Commission will verify that One Call is a privately-held corporation duly organized and existing under and by virtue of the laws of the State of Indiana. The Company is headquartered at: 801 Congressional Blvd., Carmel, Indiana 46032. The Company acquired its certificate to provide Interexchange Services under the name "**One Call Communications, Inc., d/b/a Opticom.**" One Call Communications, Inc. has changed its corporate name to One Call Internet, Inc. and filed an amended certificate of authority for a foreign corporation with the Missouri Secretary of State's Office. The Secretary of State has approved the Company's use of the name "One Call Internet, Inc."

In support of this request, I have:

- a. Attached as Exhibit 1 a current Certificate of Good Standing—Foreign Corporation for One Call Internet, Inc.; and
- b. Attached as Exhibit 2 an adoption notice and a revised tariff title sheet, with effective dates which are not fewer than thirty (30) days after the filing date of this request for approval of a change of name.


