1. On June 9, 2004, the parties appeared before the commission to provide testimony and respond to questions regarding the terms and facts surrounding the Stipulated Agreement submitted by the parties for review.
2. That the Commission requested that Respondent Coachman Homes provide a *Status Report* after one week to update the Commission on the actions taken by Coachman Homes with regard to the Respondent's actions to contact its insurance carrier with regard to Ms. Hatfield's loss.
3. That on June 16, 2004, counsel for Respondent sent a *Status Report* via regular United States mail and by facsimile to the Commission. Copies of said filings are attached hereto and incorporated by reference as if set forth more fully herein.

4. It appears from the language of the Commission's Order Directing Filings that counsel's *Status Report* was not received by the Commission.

5. That since the time of the filing of Respondent's *Status Report*, Coachman Homes has proceeded to compile a comprehensive list of all homes and customers who may have been affected by the work of subcontractor Kurt Nager and Coachman Homes is making ready the final list for submission to the Commission.

6. That Respondent has notified its insurance carrier of Ms. Dixie Hatfield's claim, as noted in the *Status Report* of June 16, 2004, and have again contacted said insurance carrier and requested that an adjuster be appointed to the file to work on the case and to contact Mr. Steve Boyd, General Manager of Coachman Homes, directly to discuss the status of the claim.

WHEREFORE, Respondent prays that the Commission accept this *Status Report* as a response to the Order Directing Filings.


