The Director of the Manufactured Homes and Modular Units Program of the Missouri Public Service Commission filed a complaint against Michael Goodwin on February 28, 2018. Counsel, Andrew Westerfeld, entered his appearance as Mr. Goodwin's attorney on April 2, 2018. A prehearing conference was scheduled for June 11, 2018, beginning at 10:00 a.m. Neither Mr. Goodwin nor his counsel appeared at the prehearing conference in person or by telephone and did not contact the Commission prior to the prehearing conference to request a continuance. The Commission will give Mr. Goodwin an opportunity to explain why he did not attend the prehearing conference.
