ORDER SETTING PREHEARING CONFERENCE

On February 28, 2018, The Director of the Manufactured Homes and Modular Units Program of the Missouri Public Service Commission filed a formal complaint against Michael Goodwin. A prehearing conference was scheduled for June 11, 2018, which Respondent failed to attend. Respondent informed the Commission that the failure to appear was due to an administrative error. Therefore, in order to discuss the procedural schedule and possible settlement of this matter, the Commission will reschedule the prehearing conference.
