4. L.W. Sewer Corporation will be converted into a nonprofit sewer company pursuant to §§ 393.827 to 393.861 RSMo (*see* proposed Articles of Conversion, Amendment, and Acceptance, App. B). Upon approval of this Commission, L.W. Sewer Corporation will accept to operate as a nonprofit corporation under Chapter 355, RSMo. The new nonprofit sewer company will be renamed L.W. Sewer Company. Upon completion of this conversion and this Commission's approval L.W. Sewer Company will not be subject to the jurisdiction of this Commission as provided for under § 393.847.2, RSMo.

- 5. Pursuant to Chapter 393 RSMo, L.W. Sewer has amended its articles of incorporation to reflect the elimination of all outstanding stock, change in membership and directorship to persons who receive sewer services, and alteration of the sewer company's governance and conduct (*see* App. B).
- 6. L.W. Sewer Corporation has no pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of the Application. No Missouri annual reports or assessment fees are overdue.
