## ORDER AUTHORIZING CHANGE IN TELECOMMUNICATIONS SERVICE AREA

On July 29, 2021, Bandwith.com CLEC, LLC (the "Company") filed a notice of change application seeking to change its authorized service area to statewide. The Company was originally authorized in Case No. LA-2008-0120 to provide service in only portions of Missouri.

The Commission has reviewed the application filed by the Company and finds that it and the attached affidavit comply with the filing requirements set forth in subsection 392.611.4 and Section 392.550, RSMo 2016. The affidavit attached to the application represents that the Company has not had contact with the Office of the Commission about any substantive issue connected to the filing within 60 days before filing the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing requirements of Commission Rule 20 CSR 4240-4.107(1).

### THE COMMISSION ORDERS THAT:

1. Bandwith.com CLEC, LLC is authorized to change its service area for providing telecommunications in the state of Missouri to statewide.
2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-

4.017(1) are waived.

3. This order shall become effective on August 16, 2021.
4. This file shall close on August 17, 2021.
