ORDER AUTHORIZING CHANGE IN TELECOMMUNICATIONS SERVICE AREA

Issue Date: July 27, 2023 Effective Date: August 7, 2023

On July 27, 2023, Time Warner Cable Information Services (Missouri), LLC d/b/a Time Warner Cable, filed an amended notice of change application seeking to change its authorized service area. Time Warner Cable requests the addition of certain service areas, including Green Hills Telephone Corporation, in the Knoxville and Polo Exchanges; Lathrop Telephone Company, in the Lathrop exchange; and MoKan Dial, Inc., in the Freeman exchange. Time Warner Cable was originally authorized to provide service in its current service area in File No. LA-2004-0133.

The Commission has reviewed the application and affidavit filed by Time Warner Cable. The Commission finds that the amended application and the attached affidavit comply with the filing requirements set forth in subsection 392.611.4 and Section 392.550, RSMo 2016. The affidavit attached to the application represents that the Time Warner Cable has not had contact with the Office of the Commission about any substantive issue connected to the filing within 150 days before filing the application. Based on that representation, for good cause shown, the Commission will waive application of the pre-filing requirements of Commission Rule 20 CSR 4240-4.017(1).

THE COMMISSION ORDERS THAT:

- 1. Time Warner Cable is authorized to enlarge its service area to include:
 - a. Green Hills Telephone Corporation in the Knoxville and Polo exchanges;
 - b. Lathrop Telephone Company in the Lathrop exchange; and
 - c. MoKan Dial Inc. in the Freeman exchange.
- 2. The pre-filing notice requirements of Commission Rule 20 CSR 4240- 4.017(1) are waived.
 - 3. This order shall become effective on August 7, 2023.
 - 4. This case may be closed on August 8, 2023.
