**MOTION TO ACCEPT CORRECTIONS TO AMEREN MISSOURI  
WITNESSES MATT MICHELS’, WILLIAM M. WARWICK’S  
and STEVEN M. WILLS’ PRE-FILED REBUTTAL TESTIMONY**

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri” or “Company”), and in filing its *Motion to Accept Corrections to Ameren Missouri Witnesses Matt Michels’, William M. Warwick’s and Steven M. Wills’ Pre-filed Rebuttal Testimony* (“Motion”) states as follows:

1. It has come to Ameren Missouri’s attention that there are minor errors in the pre-filed Rebuttal Testimony of Ameren Missouri witnesses Matt Michels, William Warwick and Steven Wills.
2. Accordingly, Ameren Missouri seeks leave of the Commission to file amended versions for each of the testimonies. The change to Mr. Michels’ rebuttal is change the word “saves” to the word “costs”. That change was made on page 12, line 9.
3. The change to Mr. Warwick’s testimony is to correct a calculation error, found on page 6.
4. The change to Mr. Wills’ rebuttal is to remove a section that should have been removed but was inadvertently left in the testimony.
5. The above corrections in no way alter the conclusions reached or recommendations made in Ameren Missouri witnesses Matt Michels’, William Warwick’s or Steven Wills’ Rebuttal Testimony.

WHEREFORE, Ameren Missouri respectfully requests the Commission accept its *Motion to Accept Corrections to Ameren Missouri Witnesses Matt Michels', William Warwick's and Steven Wills' Pre-filed Rebuttal Testimony.*
