MOTION TO CLOSE CASE

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), and for its Motion to Close Case, respectfully states as follows:

1. On April 8, 1999, Four Seasons Water & Sewer Company ("Company"), citing relocation of its administrative and accounting offices, filed a motion requesting a 60-day extension of the April 15, 1999 deadline for filing its 1998 annual report. On April 13th, the Commission issued an Order granting the motion.


2. On June 9, 1999, the Company filed a motion requesting, as a result of the departure of some key Company personnel, an additional 30 days (until July 14, 1999) to file the annual report. On July 1, 1999, the Commission, in accordance with a Staff recommendation filed on June 29th, granted the requested extension.

3. The Company filed the subject annual report on July 23, 1999. Although the report was filed a few days late, the Company was substantially in compliance with its obligation under the law. Accordingly, the Staff recommends that this case be closed.

WHEREFORE, the Staff respectfully requests that the Commission issue an Order closing this case.


