- On May 15, 2009, AmerenUE filed its Verified Petition to Change its Infrastructure System Replacement Surcharge with the Missouri Public Service Commission.
- 2. The first sentence in Paragraph 18 of the Verified Petition provides as follows:

In determining the appropriate monthly ISRS charge, the proposed rate schedule is based on a reasonable estimate of billing units in the period in which the charge will be in effect, utilizing customer class counts determined in the Rate Case.

- 3. In fact, the billing units used to develop the proposed rate schedule are based on customer class counts for the 12 months ending March, 2009, not those determined in the Rate Case. This method of developing the proposed rate schedule was agreed to by the Staff and the Company and is reflected in the Appendix C provided with the Verified Petition.
- 4. As a consequence, AmerenUE requests permission to amend its verified petition to change the first sentence in paragraph 18 to read as follows:

In determining the appropriate monthly ISRS charge, the proposed rate schedule is based on a reasonable estimate of billing units in the period in which the charge will be in effect, utilizing average customer class counts for the 12 months ended March, 2009.

WHEREFORE, AmerenUE respectfully requests that the Commission grant it authorization to amend its Verified Petition as set forth herein.
