MOTION TO CLOSE CASE

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Close Case states as follows:

1. On December 2, 1998, Digital Internet Access Link, Inc. (Complainant) filed a Complaint with the Commission against GTE Midwest, Inc. (Respondent). On January 25, 1999, Respondent filed a Request for Mediation.
2. The Complainant and Respondent attempted to resolve the dispute through mediation, and on September 23, 1999, the Commission received a letter from the University of Missouri Community Mediation Service indicating that the mediation was unsuccessful at reaching a satisfactory agreement between the parties. The letter further stated that the Complainant was instructed to contact the Commission should it want to reactivate the claim. A copy of the Community Mediation Service letter is attached as Appendix A.
3. Over a year has passed since the mediation attempt and the Complainant has not contacted the Commission asking to reactivate the claim.

WHEREFORE, the Staff respectfully requests that the Commission close this case.
