MOTION TO RESCHEDULE PREHEARING CONFERENCE

COMES NOW Intervenor Platte County Regional Sewer District ("PCRSD"), pursuant to Missouri Public Service Commission ("Commission") Rules 4 CSR 240-2.080 and 4 CSR 240-2.090, and respectfully requests the Commission to reschedule the Prehearing Conference in this matter now set for November 13, 2009. In support of its Motion, PCRSD states as follows:

1. The Commission's *Notice of Pre-Hearing Conference and Order Directing Filing* entered in this matter on November 3, 2009, includes the scheduling of a prehearing conference to convene at 9:00 a.m. on November 13, 2009.

2. Robert H. Shaw, co-counsel for PCRSD, has a pre-existing court conflict on the November 13 date which cannot be changed. Given other conflicts the first part of the following week involving the NARUC Annual Convention, and not wishing to unduly delay the prehearing conference, PCRSD respectfully would suggest that the Prehearing Conference be rescheduled to the morning of Friday, November 20, 2009, convening at 9:00 a.m., a one-week delay. PCRSD appreciates the Commission's accommodation of the parties and counsel by permitting appearances by telephone and would respectfully request that such arrangements again be implemented.

3. PCRSB has confirmed other counsel and parties' availability on the November 20 date and is authorized to state to the Commission that counsel for the Applicant, the Staff of the Commission and the Office of the Public Counsel do not object to the specific relief requested herein.

WHEREFORE, Platte County Regional Sewer District respectfully moves the Commission to reschedule the Prehearing Conference in this matter to Friday, November 20, 2009, as requested herein.
