**MOTION TO RESCHEDULE START TIME OF EVIDENTIARY HEARING**

COMES NOW Joint Applicant Aquila, Inc. (“Aquila” or the “Company”) and for its request for a later start time for the evidentiary hearing in the captioned matter states as follows:

1. On April 18, 2007, the Commission issued an Order Granting Request for Hearing and Setting Procedural Schedule pursuant to which it scheduled an evidentiary hearing for May 23, 2007 to commence at 8:30 a.m.
2. Aquila requests that the 8:30 start time be moved back to 10:00 a.m. in order to give attorneys and witnesses from the Kansas City area time to travel to Jefferson City that morning. Otherwise, an 8:30 start time will require a number of individuals to travel in the evening before and to stay over night.
3. Aquila does not believe the hearing will be particularly involved and likely will be able to be concluded by noon or shortly after even taking into account a later start time. Consequently, it believes a modification of the procedural schedule of this nature will create no inconvenience.

4. Aquila has discussed this request with representatives of PCEC, Staff and the Office of the Public Counsel, none of whom have indicated no objection to a modification of the procedural schedule of this nature.

WHEREFORE, Aquila requests the Commission modify its procedural schedule by moving the start time from 8:30 a.m. to 10:00 a.m. on May 23, 2007, and for such other orders and relief as are appropriate in the circumstances.
