JOINT MOTION TO SUSPEND PROCEDURAL SCHEDULE

COME NOW Kansas City Power & Light Company (“KCP&L”), KCP&L Greater Missouri Operations Company (“GMO”)(collectively “Company”) and the Office of the Public Counsel (“OPC”)(together “Signatories”), pursuant to Missouri Public Service Commission (“Commission”) Rule 4 CSR 240-2.080, request that the Commission suspend the procedural schedule, pending approval of the Stipulation and Agreement (“Stipulation”) filed on June 5, 2017:

1. On June 5, 2017, the Signatories filed a Stipulation which, if approved by the Commission, would resolve all issues in this matter.

2. Pursuant to the *Order Adopting Procedural Schedule* issued on February 1, 2017, KCP&L and GMO are scheduled to file rebuttal testimony on June 16, 2017. Surrebuttal testimony is scheduled to be filed on July 14, 2017, and evidentiary hearings are scheduled for August 1-2, 2017.

3. In order to promote judicial economy and avoid the unnecessary use of resources by the Commission and the Signatories, the Signatories respectfully request that the

Commission suspend the procedural schedule, pending consideration of the Stipulation filed on June 5, 2017.

4. Staff has no objection to this motion.

WHEREFORE, the Signatories respectfully request the Commission issue an Order suspending the procedural schedule, pending consideration of the Stipulation and Agreement in this matter.
