REGARDING THE ORDER OF WITNESSES**


COMES NOW Missouri Retailers Association (MRA) and respectfully states as follows:

1. On January 12, 2011, the Commission issued its Order setting blocks of exhibit numbers, and also adopting KCPL's proposed hearing schedule.
2. Per the schedule adopted by the Commission, the Iatan 1 and Iatan 2 issues will be presented beginning January 18, 2011, and continuing through January 25, 2011.
3. Because MRA's witness, Mr. Walter Drabinski, will be traveling from Key West, Florida, MRA respectfully requests that Mr. Drabinski's appearance on the stand be scheduled beginning January 24, 2011, and continuing as necessary.
4. Counsel has consulted with counsel for KCPL and the Staff. KCPL has no objections to this arrangement, conditioned on examination of its witnesses being completed prior to cross-examination of Mr. Drabinski. Staff voiced no objection to this arrangement.

WHEREFORE, MRA renews its request that Mr. Drabinski's cross-examination be scheduled beginning January 24, 2011.


