Mercury Wireless Kansas, LLC ("Mercury Wireless" the "Company" or "Applicant"), respectfully submits this Motion for Correction/Rehearing:

1. The Commission issued its Order Granting Application for Designation as an Eligible Telecommunications Carrier in this proceeding on November 15, 2018.

2. In its Order, the Commission stated: "Mercury is a mobile wireless carrier whose operations are not regulated by the Commission." (Order, p. 3).

3. As shown in Mercury's verified application, it uses fixed wireless technology and has registered as an iVOIP provider with the Commission. (Application, para. 2). See also Staff recommendation, para. 3, and File No. DA-2019-0082.

4. Accordingly, Mercury requests that the Commission correct the Order, by revising the statement set forth above such as by changing it to read: "Mercury is an iVOIP provider that is duly registered with the Commission."

WHEREFORE, Mercury Wireless respectfully requests that the Commission to correct/rehear its November 15, 2018 Order as requested herein and grant such other and further relief as the Commission deems appropriate.
