MOTION FOR ISSUANCE OF A PROTECTIVE ORDER

Comes now Southern Union Company ("Southern Union") and pursuant to 4 CSR 240-2.085 moves the Missouri Public Service Commission ("Commission") to issue its standard-form protective order in the above-referenced case. In support thereof, Southern Union respectfully states to the Commission as follows:

- 1. On this same date, Southern Union is filing an application with the Commission wherein it requests an order authorizing the acquisition by Southern Union, directly or indirectly, of up to and including one hundred percent (100%) of the equity interests of Panhandle Eastern Pipeline Company ("Panhandle Eastern") including its subsidiaries.
- 2. Southern Union will file as an appendix to the application the Stock

 Purchase Agreement among Southern Union and others. Southern Union will also file

 as an appendix to the application pro forma financial statements which show the effect

 of the proposed transaction on Southern Union. Because the Stock Purchase

 Agreement contains confidential and proprietary information regarding the acquisition

and the pro forma financial statements contain confidential and proprietary information regarding Southern Union's financial circumstances, Southern Union requests that the Commission issue a Protective Order in this case so that these documents may be filed as "highly confidential." Southern Union anticipates that there also may be additional confidential or proprietary information requested by the Commission Staff and/or the Office of the Public Counsel as they conduct their review of this transaction for which a protective order would be necessary.

- 3. None of the information for which a claim of confidentiality is made can be found in any format in any other public document.
- 4. Therefore, because of the potential for public disclosure of such information without a protective order in place, Southern Union moves the Commission to issue its standard-form protective order containing classifications of "highly confidential" and "proprietary."

WHEREFORE, Southern Union respectfully moves the Commission to:

- (a) issue its standard-form protective order containing classifications of "highly confidential" and "proprietary"; and,
 - (b) grant such further relief as the Commission deems appropriate.
