6	Q.	Please state your name and business address.		
7	A.	Michael L. Moehn, Ameren Services Company (Ameren Services), One		
8	Ameren Plaza, 1901 Chouteau Avenue, St. Louis, Missouri.			
9	Q.	What is your position with Ameren Services?		
10	A.	I am the Vice President of Corporate Planning, which provides support		
11	services to the Ameren operating companies, including Union Electric Company d/b/a			
12	AmerenUE (AmerenUE or Company).			
13	Q.	Please describe your educational background and employment		
14	experience.			
15	A.	I graduated from St. Louis University in 1991 with a Bachelor of Science		
16	degree in Accounting. I received my Masters in Business Administration in 2000 from			
17	Washington University. I am a licensed Certified Public Accountant in the State of Missouri			
18	and a member of the American Institute of Certified Public Accountants and the Missouri			
19	Society of Certified Public Accountants. I have also recently completed the Reactor			
20	Technology Course for Utility Executives at the Massachusetts Institute of Technology.			
21		I have been with Ameren Services since 2000, first as the Assistant Controller,		
22	then in 2001 as Director of Corporate Modeling and Performance Management. In 2002, I			
23	was promoted to Vice President of Shared Services. I assumed my current position as Vice			

- 1 President of Corporate Planning in 2004. Prior to my employment at Ameren, I was
- 2 employed by Price Waterhouse LLP (now PriceWaterhouseCoopers LLP) as Senior Manager
- 3 in the company's Audit and Business Advisory Services Department.
- 4 Q. What is the purpose of your testimony?
- 5 A. The purpose of my testimony is to sponsor AmerenUE's Integrated Resource
- 6 Plan, which was submitted in this case on December 5, 2005 and is incorporated herein by
- 7 reference. The filing consisted of 17 volumes, some portions of which have been marked as
- 8 proprietary or highly confidential.

- 9 Q. Do you have any additions or changes to the filing?
- 10 A. Yes. On August 15, 2006, Staff and AmerenUE filed a Joint Stipulation and
- 11 Agreement (Stipulation). In the Stipulation, AmerenUE agreed to undertake certain demand-
- side management and energy efficiency (referred to collectively as DSM) analyses.
- 13 AmerenUE has already begun this work and has included the parties in this case
- 14 (stakeholders) in this process as laid out by the Stipulation. AmerenUE has sent out a
- 15 Request for Proposals (RFP) which was drafted with the assistance of participating
- stakeholders. After reviewing and evaluating the responsive bids, the stakeholders and
- 17 AmerenUE narrowed the field to three bids and brought each of those bidders into St. Louis
- 18 for a face-to-face interview. After the interviews were completed, a preferred bid was
- selected. This selection was agreed upon by all participating stakeholders. AmerenUE is
- 20 excited by both the decision reached by the group and the progress made under the
- 21 Stipulation to date. AmerenUE would ask the Commission to consider the terms of the
- 22 Stipulation as modifying and, accordingly, as a part of its December 5, 2005 filing.
 - Q. Have there been any further settlement discussions among the parties?

Direct Testimony of Michael L .Moehn

- 1 A. Yes, productive settlement discussions continue between all parties.
- 2 However, the recent ice and snow storm prevented the parties from further pursuing these
- discussions. AmerenUE now believes that a comprehensive settlement of these proceedings
- 4 is possible and is continuing settlement discussions this week.
- 5 Q. Does this conclude your direct testimony?
- 6 A. Yes, it does.
