# MOTION TO EXTEND EFFECTIVE DATE OF FIXED BILL PILOT PROGRAM AND FILING OF CORRECTED TARIFF SHEETS

COMES NOW Aquila, Inc., d/b/a Aquila Networks-MPS and Aquila Networks-L&P ("Aquila" or the "Company") and states the following:

1. On April 13, 2007, Aquila caused to be filed with the Commission its request for an extension of and changes to the Company's Fixed Bill Pilot Program ("Program"). In that regard, the Company filed tariff sheets bearing an effective date of July 1, 2007.

### **Extension of Existing Program**

- 2. The Company's existing Program for its Aquila Networks-L&P division ("L&P") will terminate on May 31, 2007 unless extended as provided by the language of the governing tariffs.<sup>1</sup>
- 3. To facilitate a review of Aquila's request for an extension of and changes to its Program, Aquila also requests that the effective date of the existing L&P Program be extended by thirty (30) days until June 30, 2007. This will avoid the circumstance of customers using the existing Program being terminated and being required to re-subscribe to the service.

#### **Submission of Corrected Tariffs**

4. At the time the proposed new tariff sheets were filed on April 13, 2007,<sup>2</sup> the issued date was inadvertently omitted. Attached hereto are corrected tariff sheets bearing an issued date of April 20, 2007 and an effective date of July 1, 2007. No other changes to the tariff sheets have been made. These tariff sheets will supercede those filed on the 13th.

WHEREFORE, for the reasons aforesaid, Aquila requests that (1) the date for the termination of its existing Fixed Bill Pilot Program in its L&P service area be extended until June 30, 2007 and, further, (2) the corrected tariffs sheets attached hereto be substituted as the corrected Schedule DO-1 to Dennis Odell's Direct Testimony.
