STAFF'S MOTION TO LATE-FILE REPLY TO UNION ELECTRIC COMPANY'S RESPONSE TO THE STAFF'S PROPOSED PROCEDURAL SCHEDULE

Comes now the Staff of the Missouri Public Service Commission (Staff) and requests leave to late-file its reply to Union Electric Company's (UE) June 16, 2000 response to the Staff's May 30, 2000 proposed procedural schedule. In support of the Staff's Motion To Late File Reply, the Staff states as follows:

- 1. On June 16, 2000, UE filed Union Electric Company's Response To The Staff's Proposed Procedural Schedule. The Commission's Rule 4 CSR 240-2.080(16) provides that "[p]arties shall be allowed not more than ten (10) days from the date of filing in which to respond to any pleading unless otherwise ordered by the commission." Thus, the Staff's responsive pleading was required to be filed on or before June 26, 2000.
- 2. Due to the press of other Commission business, Staff counsel missed the Commission filing deadline, prescribed by 4 CSR 240-20.080(16). Staff counsel apologizes for any delay or inconvenience that this missed deadline has caused or may cause the Commission or any of the parties. Staff counsel takes filing deadlines seriously, although unfortunately that may not appear to be the case.



Wherefore the Staff requests that the Commission grant leave for the Staff to late-file Staff's Reply To Union Electric Company's Response To The Staff's Proposed Procedural Schedule.
