This registration report must be filed within three months after your incorporation/qualification date to avoid late fees. ***Failure to file this report will result in administrative dissolution of your corporation, and the inability to legally conduct business in Missouri.***

After filing the initial annual or biennial registration report, you must file an annual or biennial registration report every year or every two years based on your incorporated /qualified month.
